## Admission

Willing Candidates have to submit their application in prescribed format to our office within 40 days of the notice publication with following papers.

- SLC/ CLC
- Marks Sheet of 10+2/ Sr. Secondary Board Examination/ or Equivalent Exam.
- Secondary Board Certificates (Provisional Certificate, if Board Certificate not yet available)
- Marks Sheet/ Certificate of 10th Examination.
- Self addressed two small envelopes of size 11 cm X 22 cm with RS. 25/postage stamp affixed.
- Female, in good health.
- The minimum age for a admission shall be 17 years on or before 31st December of the year in which admission sought. The maximum age for admission shall be 35 years.
- Education Qualifications: 10+2 any stream pass or equivalent
- Minimum age 17 to 35 years. No age bar for ANM/ LHV
- 10+2 class passed preferably science
- Admission & Counseling programme organized as per norms of INC, Govt. of India. The course duration for the ANM/ GNM course is for 2 years & 3 & <sup>1</sup>/<sub>2</sub> years respectively.
- The aspirants for both these courses are required to go through written test/ interview as arranged by the Admission Committee
- Before the actual admission, the students will be required to submit requisite documents to the Admission Committee for verification.
- The student shall be admitted only once in a year. The seat allocated for ANM/ GNM courses as per INC

• After going through proper counseling, written test, interview & documents verification, the list of selected candidates will be displayed on the notice board of the institute and the candidate is intimated by post / email & by phone.

Our Endeavour to start B.Sc. Nursing course is in advance process of recognition & in the incoming the current year, we propose to commerce B.Sc. Nursing Classes.

Several useful Medical / Nursing & IT Courses including other professional programmers under Skill Development Entrepreneurship Scheme of the Govt. of India are being run under academic premises of our different technical units & run under recognition from DGE&T, NCVT, Govt. of India. Some Salient features of these training programs are-

- These are short term training programs.
- All admission in these courses & teaching facility to the trainee participants will be free of cost.
- Organization provides Placement Assistance after value added training programme.

As per the list enumerating these short term MES courses, it is apparent that it includes many useful Medical, Nursing, Hospital, ICT, Beauty care & Life skill courses. All these skills enhancement training Program add to the income & financial capabilities of the trainees as it will create basic employment opportunities for them.

Education and health care are two fields that have seen tremendous advancement in recent past. The demand for professionally trained personnel in the large and growing field of Nursing and Para-Medical Sciences has transcended the geographical boundaries with some leading developing and developed nations turning to India for trained and qualified personnel in this sphere.

However it has to be conceded that the nation, as a whole, still lacks adequate no. of Para-Medical & Nursing Personnel to properly look after the growing health care needs of the masses and to maintain acceptable Health-workers & Population ratio. Now there is increasing demand for allied health personnel in health care and nursing health care organizations including hospitals & nursing homes etc who are today anxiously looking towards the universities and the vocational institutes to provide them with requisite nursing personnel. Hence serious and concerted steps need to be taken in this respect. Our different technical units established under the umbrella of Ambedkar Group of Institutions have been for the preceding several years, imparting standard training programs in various useful vocational/ professional courses in Allied Medical, Para-Medical, Management, IT & other sectors being run under Govt. of India approved universities under distance education program.

### Facilities

- Scholarship Facility: Scholarship facilities SC/ ST and OBC students have special scholarship facility. Poor boys from the General Category are also provided scholarship as per merit test. In this regard, the students are required to submit the relevant Residential & Caste Certificate along with income certificate of the parents.
- Hostel Facility: Hotel Facilities are being made available separately to boys & girls, students. Cent-percent hostel facility is provided to all the girl's candidates in Nursing and Para-Medical courses in the institute premises itself. At the same time the willing male students are being provided with suitable hostel facility in separate campus.
- **Transport Facility:** Our students are being extended transportation facility to take them to Govt. hospitals and eminent Nursing homes for practical cum observation facility. We also provide this facility to Para- Medical students for outdoor training and excursion trips.
- Cultural Activities: From time to time, on the occasion of inauguration and concluding of the academic session as well as on some occasions of national importance such as Gandhi Jayantee, Republic Day, Independence Day, Dr. Ambedkar's Jayantee etc. various cultural activities are undertaken in the institutes' premises and our students actively participate in these programmes. This interaction among the students beings forth the natural talents in them and help in the personality development of students.
- Symposiums & Seminars: Symposiums & Seminars are organized at regular intervals on different topics concerning science & relevant important topics in which the students' professionals & prominent personalities actively participate in the deliberations. Our main objective behind holding such deliberations is to bring about a mass awareness among the masses & create interest in scientific learning's.
- **Sports & games Facility:** A specious common Room, located in the centre of the premises, provides several indoor games facilities to the students such as carom, chess, table-tennis etc. Besides the academic premises have a multi-

purpose ground where students enjoy playing volleyball, badminton etc with eases & comfort.

- Library & Reference Section:
  - Library & Reference Section: It comprises a collection of authentic books on different trades. Journals, Magazines, CDs & News Paper for the benefit of the trainees.
  - **Computer Lab Faculty:** We have a well equipped Computer Lab, with Wi-Fi facilities for the benefit of the students.
- Educational & Excursion Trips: From time to time, tours to places of academic and technical interests are arranged by the institute as per academic requirements of the courses and to keep the students afresh in their studies.
- Laboratory Facility: One distinguishing feature of this institute is the possession of well equipped and properly maintained clinics and laboratories in the sphere of various Para-Medical sectors &other relevant useful trades. We will be developing & enriching these labs as per the requirements of the courses & the demand of modern technologies. Our final Endeavour is to develop these labs into one of the idea laboratories in the state in its specialized field.
- **Medical Facility:** Health check up of the students is being carried out by the institute at regular intervals. We organize health awareness campaign in the area and also from time hold free Health checkup camps in backward & rural area as well.
- We have a double storied spacious building at Durgadih, Bikramganj, Rohtas with a 100 Bed capacity. This is being strengthened with furniture's equipments, accessories and requisite technical man-power association. The proposed hospital is going to operate shortly in the area.
- We are soon going to introduce a 100 Bed Super Specialty Hospital at Danapur Patna with specialization in gynecology & child diseases.

#### Compliance to the Code of Conduct-

There is a code of conduct for the participant trainees in different courses and they are required to strictly follow & comply to the guidelines & instructions as issued by the institute from time to time. Otherwise it may invite disciplinary & penal actions against the defaulting student.

#### **EXAMINATIONS:**

Candidates having less three 80% attendance in classes and less than 50% marks in internal examination may be debarred from appearing in the final examination. The examination will be held as per schedule fixed up by the Deptt. of Health, Govt. of Bihar, Indian Nursing Council, Govt. of India or the relevant Govt. of India approved Universities in case of Management & IT courses.

#### **IDENTITY CARD:**

Students will be issued in Identity Card and the students are supposed to always hold it till the completion of the courses. Students are desired to come to the institute along with this identity card regularly.

#### **CERTIFICATION:**

Certificates will be issued by the Deptt. of Health, Govt. of Bihar, BNRC, Indian Nursing Council & the Govt. of India approved universities as per relevance of the courses.

#### ANTI-RAGGING UNDERTAKING

All candidates selected for admission and their parents & guardians will be required to give a combined undertaking that he/ she was not involved in any activity in the past and that he/ she would not indulge in it for future. If the undertaking is violated, the students would be liable to be expelled even (Directives of the Hon. Supreme court of India)
